

**2019 Modern Rock Ship Rocked Giveaway**

**Official Rules**

CONTEST OPEN TO PERMANENT LEGAL U.S. RESIDENTS WHO ARE AT LEAST 21 YEARS. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL FEDERAL, STATE AND LOCAL REGULATIONS APPLY.

1. **HOW TO ENTER.** By entering, you agree to comply with all applicable laws and these Official Rules, and you agree to abide by all decisions of the Sponsors. Only one entry per person, per household. To qualify participants must listen to WRMR, Modern Rock 98.7, Monday –Friday for the Ship Rocked Giveaway sounder which will air seven (7) times a day at random each weekday. Caller number nine (9) after the sounder airs will be qualified for the Giveaway.
